



Osceola County Farm Bureau Scholarship

Deadline for applications: April 1, 2019

Eligibility:

1. The applicant or his/her parents must be a member of the Osceola County Farm Bureau.
2. The applicant must be a high school senior or graduate accepted by or attending a post-secondary educational institution or vocational program.
3. The applicant may reapply for this scholarship each year.
4. The student's grades and need for the scholarship will be taken into consideration.
5. The recipient(s) of the scholarship will be selected by the Osceola County Farm Bureau Board of Directors.
6. The scholarship money will be awarded after the student has completed his/her first semester of the 2019 – 2020 school year and has maintained a grade point average of at least 2.0 on a 4.0 scale or equivalent.
7. Grades must be received in the county office by February 1, 2020.

Application Procedure:

1. Complete all sections of the application for the Osceola County Farm Bureau Scholarship.
2. Attach an official transcript of the applicant's school courses and grades.
